THE CENTERS' EXERCISE CLASSES ARE WELL ATTENDED, WITH 973 SENIORS PARTICIPATING ANNUALLY. SENIORS PARTICIPATING IN THE EXERCISE CLASSES REPORTED AN INCREASED LEVEL OF PHYSICAL ACTIVITY, IMPROVED THEIR ABILITY TO MANAGE THEIR WEIGHT, HAD INCREASED STAMINA AND BALANCE, HAD AN ENHANCED MOOD, AND HAD MADE PROGRESS IN CONTROL OF THEIR BLOOD PRESSURE.
